## **Objective**

The Fund's objective is to provide Ordinary (Ord) shareholders with a high level of income, with the potential for income and capital growth, and to provide Zero Dividend Preference (ZDP) shareholders with a pre-determined final capital entitlement of 127.25p per ZDP share on the planned winding up date of 1 July 2024.


## **Investment style: Value**

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

#### Investment commentary

The US aside, most equity markets struggled during the month, responding to the strong dollar, emerging market stress and suggestions of lower Chinese and European growth. The FTSE All-Share fell by 2.8%, not helped by its significant exposure to miners. Less encumbered in this respect, the NSCI (XIC) slipped by 0.7%. The Fund secured a modest but positive return of 0.2%, on which style effects had negligible effect.

At the stock level, the biggest winners were companies that issued interim results in the month. TT Electronics and TI Fluid Systems both generate the majority of their revenues overseas and their results benefited accordingly. Perhaps more surprisingly, Restaurant Group, which operates chains such as Frankie & Benny's, confounded the gloom surrounding the domestic economy to announce satisfactory numbers: benefiting from new management, it has returned to like-for-like sales growth.

The largest loser was Wincanton, which announced a revised pension deficit recovery plan and was affected by concern about the logistics sector following House of Fraser's problems. Meanwhile, Just Group, the annuity provider, was again a poor performer: the PRA's review of the value of investments in equity release mortgages is likely to require the raising of additional equity capital


Though not affecting the fund during August, there are signs of renewed M&A activity after a quiet summer, while IPOs also look set to pick up again.


