The Fund is a split capital investment trust – a type of investment company, or collective investment fund – with Premium (Ord) & Standard (ZDP) share listings on the Main Market of the London Stock Exchange.

## **Objective**

The Fund's objective is to provide Ordinary (Ord) shareholders with a high level of income, with the potential for income and capital growth, and to provide Zero Dividend Preference (ZDP) shareholders with a pre-determined final capital entitlement of 127.25p per ZDP share on the planned winding up date of 1 July 2024.

It is the Directors' current intention that, in the absence of unforeseen circumstances, the Fund will declare dividends totalling not less than 4 pence per Ord share in respect of the initial period to 30 June 2018. # Investment style: Value

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

## **Investment commentary**

UK indices were weak in February, consistent with the other global markets. Large companies, represented by the FTSE All-Share, generated a total return of -3.3% and the NSCI (XIC) returned -3.2%. Size factors mattered little over the month, but style data showed value trailing growth.

There was a notable revival in corporate activity in the small company universe. This benefited travel management company Hogg Robinson, whose share price responded positively to the news of a bid from American Express, together with the parallel sale of their expense management business to Visa. Elsewhere, the market responded well to a change of chief executive at communications and IT services provider KCOM. Education technology provider RM revealed improved results and acquisition synergies higher than previously expected.


Performance was hindered by commercial vehicle hire company Northgate whose strategy is being overhauled by new management; this resulted in earnings downgrades that disappointed the market. International consultancy firm RPS issued a profit warning, reporting higher costs and weaker trading in their Energy division. More generally, the broader pull-back in markets hurt several share prices. Among the poorer performers were filters and packaging products manufacturer Essentra, neighbourhood retailer McColl's and Keller, a global ground engineering business.


