The Fund is a split capital investment trust – a type of investment company, or collective investment fund – with Premium (Ord) & Standard (ZDP) share listings on the Main Market of the London Stock Exchange.

Objective

The Fund's objective is to provide Ordinary (Ord) shareholders with a high level of income, with the potential for income and capital growth, and to provide Zero Dividend Preference (ZDP) shareholders with a pre-determined final capital entitlement of 127.25p per ZDP share on the planned winding up date of 1 July 2024.

It is the Directors' current intention that, in the absence of unforeseen circumstances, the Fund will declare dividends totalling not less than 4 pence per Ord share in respect of the initial period to 30 June 2018. Investment style: Value

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

Investment commentary

July was a good month for small companies. In a busy period for results, businesses exposed to the domestic economy have generally surprised positively; this benefited the more domestically oriented NSCI (XIC). Allied to that, lower exposure to the dollar benefited the small and mid cap indices compared to the more internationally exposed FTSE 100. The FTSE All-Share Index generated a total return of 1.2% over the month and the NSCI (XIC) returned 2.9%. The Fund produced a total assets total return of 4.0%. This represents the ungeared portfolio return excluding the impact of the June transition from Aberforth Geared Income Trust and launch costs. In what was a good month for small cap share prices, the trust benefited from having a fully invested portfolio at launch.

Style factors mattered little over the month but at the stock level there were several notable winners. These included PR company Huntsworth and neighbourhood retailer McColl's, both of which reported strong interim results. Games Workshop, which manufactures miniature wargames, was another stand-out performer on results. Housebuilding and construction group Galliford Try reassured the market with a solid year end trading update. Lloyd's insurer Novae responded positively to the news of a bid from Bermuda-based AXIS Capital. There was a notable revival in M&A in the small company universe over the month, with a total of four new deals announced in July, including Novae.

The only notable detractor from returns was Eurocell; the share price was affected by weak news flow from a competitor in the windows and doors market.




