Fund structure

Objective

The investment objective of the Fund is to seek to achieve a total return, calculated on an income reinvested basis, greater than the Deutsche Numis Smaller Companies Index (excluding Investment Companies) over the long term, with the focus on rolling five year periods.


Investment style: Value

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

Monthly investment commentary: October

Global equities enjoyed positive returns in October with Japan, emerging markets and the US tech sector leading the way. The UK large cap dominated FTSE All-Share benefited in part from sterling's weakness against both the dollar and euro and rose by 3.7%. Its performance gap versus smaller companies so far this year opened further, with the DNSCI (XIC) rising by 0.8% in the month. The Fund lagged its benchmark, rising by 0.2%.

Rank, the gaming group, was a loser, despite its trading update revealing strong growth in the most recent quarter. Shares have suffered along with peers in anticipation of the Budget and possible change to gambling taxes. CMC Markets was also weak but on no news, having risen sharply into the September month end. Goodwin, a non-holding with a family controlling stake was a significant strong performer after reporting improvements in ongoing trading.


On to the winners, M&A remained a theme as **TT Electronics** was subject to a takeover offer from a larger Swiss competitor. Aberforth supported the eventual recommended offer, following engagement with the both the company and the would-be acquirer. Elsewhere, **Marston's** was stronger following its full year trading update. This confirmed the company is making good progress against its strategic and financial targets, with profits ahead of market expectations.



Data sources & calculations

All data supplied by Aberforth, except DNSCI (XIC) data (from Deutsche Numis/Paul Marsh and Elroy Dimson – London Business School) and FTSE data (from FTSE International Limited).

Performance returns are total returns after all expenses and assume reinvestment of dividends. Yield is based on the Fund's trailing 12 months' dividends. Active share is a measure of how the Fund's portfolio differs from the DNSCI (XIC). Small companies are represented by the DNSCI (XIC).
