Fund structure

The Fund is an authorised unit trust scheme under the Financial Services & Markets Act 2000 and also a UCITS scheme as defined by the Collective Investment Schemes Sourcebook. The Fund is open-ended and issues Accumulation (Acc) and Income (Inc) units.

The investment objective of the Fund is to seek to achieve a total return, calculated on an income reinvested basis, greater than the Deutsche Numis Smaller Companies Index (excluding Investment Companies) over the long term, with the focus on rolling five year periods.

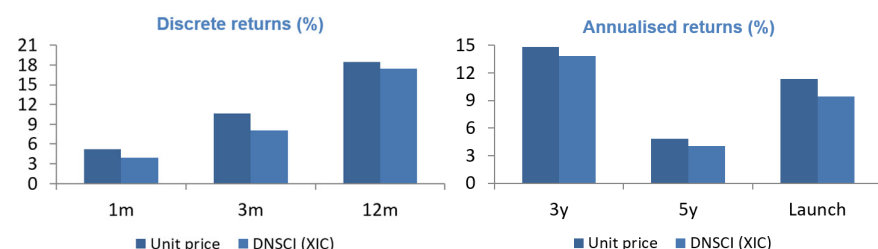
Investment style: Value

Aberforth are value investors who buy shares in companies that they calculate to be selling below their intrinsic value. This is determined through detailed financial and industrial analysis, combined with a valuation approach that focuses on both stockmarket and corporate worth.

Monthly investment commentary: August

August saw re-escalation in the Iranian conflict, contributing to higher bond yields on the expectation of more inflation. Offsetting this more challenging macro backdrop for the UK was the report of consumer confidence reaching a two-year high. Domestic stock markets advanced, with smaller companies continuing to recover ground on their large-cap peers. The FTSE All-Share returned 0.7%, behind the DNSCI (XIC) benchmark's 3.9%. The Fund outperformed, returning 5.2%.

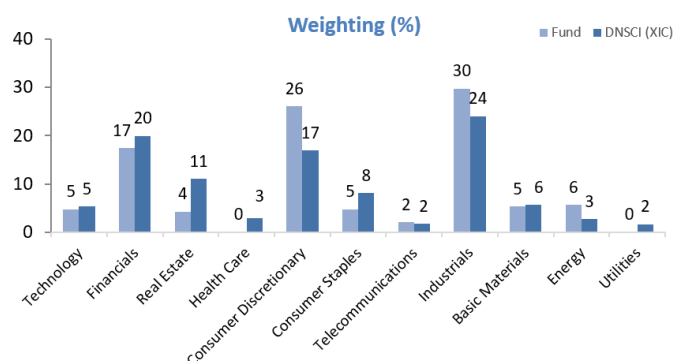
Leading the Funds winners was **Ecora Royalties**. A July trading update had highlighted the strengths of the existing portfolio. This was followed by renewed global inflationary concerns supporting the commodities over which it holds royalties in August. Elsewhere, **Dialight** continued its strong run as its business turnaround builds. Sector peer **XP Power** released results confirming order book strength, particularly from semiconductor manufacturing equipment customers. **Halfords Group** upgraded profit guidance, helped in part by the recent warm weather boosting demand for bikes and touring equipment. Conversely, **Wilmington** was weak despite a trading update bringing no great surprises. Elsewhere, **Sabre Insurance Group** gave back a little of its strong year to date performance. Results confirmed full year guidance.

Meanwhile, M&A continued to positively impact performance, with **Gamma Communications** rising after confirming discussions with potential acquirors. **Bodycote** also announced the receipt of possible offers from private equity bidders. The emergence of multiple confirmed private equity suitors in each case continues to highlight the attractive valuations on offer in UK smaller companies.

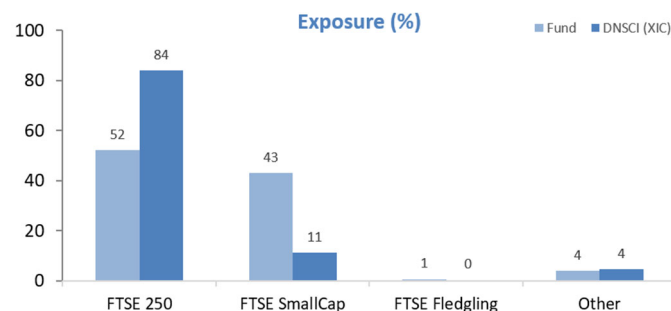

Data sources & calculations

All data supplied by Aberforth, except DnSCI (XIC) data (from Deutsche Numis/Paul Marsh and Elroy Dimson – London Business School) and FTSE data (from FTSE International Limited).

Performance returns are total returns after all expenses and assume reinvestment of dividends. Yield is based on the Fund's trailing 12 months' dividends. Active share is a measure of how the Fund's portfolio differs from the DnSCI (XIC). Small companies are represented by the DnSCI (XIC).
